

Collectively, our COD team brings over 70 years of experience in rabbit breeding and showing. We are focused on ensuring that we achieve consistency and high-quality broken English Angoras in our line. Lastly, we're also working on a new boutique for the NARBC, which will feature on-demand printing. ### **Board Meeting Minutes**

### NARBC Board Meeting November 13, 2024

The Board of Directors met on Wednesday, November 13, 2024, via Zoom. President Jen Richardson called the meeting to order at 7:46 pm EST. Board members present were Jen Richardson, Lauren Cody, June Abbott, Jackie McDonald, Andrea Evans, Laurie Penterman, Casey Jones, Tammy Vaughn and Madison Wisecup.

**Secretary Meeting Minutes-** The Board members were provided with a copy of the meeting minutes from the October 16, 2024, board meeting. A MOTION was made by Jackie McDonald to approve the meeting minutes. The motion was SECONDED by June Abbott. Motion CARRIED.

**Status of Membership-** Laurie Penterman reported that we currently have 363 members in the club, 293 being Open members, and 70 Youth members. Since our October meeting, the club has gained ten new Open members and two new Youth members. Two Open members and no Youth members renewed their membership since the last meeting. Laurie continues to send out renewal notices to expiring members via email.

**Financial Report-** June Abbott reported that the balance in the checking account is \$4,389.11, there is \$26,715.34 in the money market account, and we have a balance of \$275.69 in the PayPal account, for a total cash balance of \$31,380.14. There is \$2,075.14 in the held funds, so there are \$29,305.00 available funds.

At the 2024 ARBA Convention, the NARBC raffle table at the booth brought in \$1,030. A silent auction was held at the Angora Banquet, and the people who donated items to the auction designated where the money from their item's sale would go. A total of \$860 was made, with \$75 going to sweepstakes awards, \$360 to the Linda Cassella Memorial Youth Scholarship fund, \$210 to the general fund, \$90 to WSG, \$75 to the Youth Royalty contest, and \$50 to research and development.

**Policies and Procedures Manual Updates-** President Jen asked the question of does the Youth Director have a term? Our current Youth Director Madison Wisecup turns 19 in January and will become an Open member of the club. Casey said she remembers that in the past the Youth Director finished out their term even if they turned 19 during it. The current Policies and Procedures Manual is very long and includes many pages that are more guides for committee chairs and host clubs. The guide pages of the PPM should be a supplement. These pages are great guides, but don't need to be in the PPM. Laurie volunteered to divide the Policies and Procedures Manual Into two parts, the actual policies and procedures, and the supplement with the guide pages.

**NARBC District Facebook Pages-** What is the purpose of the NARBC District pages? In the past there were more districts that were smaller areas, so discussion on the pages was more local. District Directors should reach out to their members on their district page and ask them for ideas as to what they want to see on the district pages. Maybe Rachel Penterman could mention something about this in her next Domestic Rabbit article. Laurie will send each district director a list of members in their district.

**2024 ARBA Convention Wrap-Up-** People seemed happy and had fun. The raffle table volunteers didn't all show up. Maybe next year we can have an incentive that whoever volunteers in the booth gets raffle tickets for a chance to win a cool prize. The booth was crowded, but next year we'll have three spaces instead of two. Going forward there needs to be one person in charge of taking the money when the booth closes at night, and then making sure it is back in the booth the next morning. There was debate about putting the rabbits in carriers to the show table or having runners get and bring them to the table. Because the Angora coops and show tables were so close together, a few board members met in the showroom early the morning of judging and decided to let each breed team decide how they wanted to get their rabbits to the show table. Going forward, we will need to see how far apart the Angora coops and judging tables are. If they are close, runners work better. We also need to consider having two writers and one ramrod for breeds with classes with large class numbers. The banquet was well attended, and everyone seemed to have a good time. Vanessa Rich brought so much positive energy to this Convention through the WSG competition and the banquet.

**Judge Needed for 2025 ARBA Convention-** Laurie sent an email to the membership asking them for their ideas for who they would like to see judge Angoras at future ARBA Conventions. Twenty-four people replied, and a total of 34 different judges were suggested, but no judge received more than a few votes. Since we really need to decide on a judge for the 2025 ARBA Convention, a MOTION was made by Casey Jones to ask Rachel Penterman to judge English and Giant Angoras at the 2025 ARBA Convention in Indianapolis. The motion was SECONDED by Tammy Vaughn. Motion CARRIED.

**2025 National Angora Show Update-** Vanessa Ricch and Andrea Evans are the host committee for the 2025 National Angora Show in Decatur, Illinois. The Rabbit Renegades club is hosting the All-Breed Show they and are in charge of hiring our National Show judge, providing the judging table, sanction the Open and Youth National Angora Show through ARBA, providing a show secretary to accept entries, generate control sheets, process results and provide show reports, provide areas large enough for our silent auction, luncheon and WSG contest. NARBC is responsible for providing the awards, one clerk who will record results and assist the show secretary, one ramrod who will assist the show superintendent, NARBC sanctions for the National Angora Show, and a National Show flyer.

A MOTION to adjourn the meeting was made by Jackie McDonald. The motion was SECONDED by Andrea Evans. The meeting was adjourned at 9:35 pm EST. Our next meeting will be held on Tuesday, December 10, 2024, at 7:45 pm EST via Zoom.

There is \$1,633.14 in the held funds, so there are \$31,568.82 available funds.

#### **OLD BUSINESS**

**Policies and Procedures Manual Updates-** Since our last meeting Laurie has gone through the Policies and Procedures Manual and removed the example and guide pages and put together the actual policies and procedures. This took quite a bit of time. A couple of people will need to work on the guidebook part of the manual. As we add things they need to get into the Policies and Procedures Manual.

**Convention Updates-** June received confirmation for our 3 booth spaces being paid for in full. Our two Angora judges will be Travis Finkle and Rachel Penterman.

Committee Chairs- the following chair positions have been filled:

Elections Chair- Angel Semerling

Show Advisory Chair- Laura Clark

Awards Chair- Laura Clark working with committee members Skyler Starrett, Amanda Fritsch and Amy Kopp.

We are still in need of a Boutique Chair and a Breed Chair for the 2025 ARBA Convention. Google Doc folders will be created for the committee chairs for accountability.

#### Nationals Update-

- 1. Luncheon- The timing for the luncheon is uncertain. It would be ideal to have it when the National Angora Show ends, but there's no way to know when that will be. In Sandy Berger's contract it says Noon-1:00, but Bob Donnell can't adhere to that. Can we make an amendment to the contract? Does it need to be a everyone sits down to eat at the same time event, or could it be grab and go and people eat when they're not showing? There is a time crunch as the show is the day before Easter and people want to get on the road to get back home for Easter. The cost for the luncheon is \$20 per person. Checks can be mailed to June or payment can be made through PayPal. A google doc will be created to sign up for the luncheon, and the due date for reservations and payment will be April.
- 2. The facility is charging a rental fee of \$20 per table and \$5 per chair. This is not in our budget. Perhaps we can pay for two tables and 16 chairs so there's somewhere to sit and eat. There is \$200 in the budget for banquet decorations, so some of that could be used for the table and chair rental.
- 3. Rabbit Renegades strongly discourages National Angora Show exhibitors from entering in the All-Breed Show B since the Nationals Angora Show will be happening at the same time as Show B.
- 4. We need ramrod and writer volunteers for each Angora breed.
- 5. We need someone to oversee the raffle and silent auction. How many tables do we need? Table rent is \$20 per table.
- 6. Andrea will make a photo booth.
- 7. The Angora National Show logo isn't quite done yet. The National Show Mini Guide will be in the December *Angora News*.
- 8. Amy Netherton is making the awards under contract.

**Mentor/Social Media-** Rachel Penterman and Tammy Vaughn are the NARBC Mentoring Group co-chairs. They do not want to set up mentors, but they want the NARBC Mentoring Facebook page be a place where new members can get information. Laurie will give the names of new members to Rachel and Tammy to reach out to these new members. Will still be mentoring, but also welcoming and answering questions. Tammy said she would be on the Facebook page but not be an administrator.

#### **New BUSINESS**

Honorary Lifetime Memberships- Laurie sent an email to the board about Lifetime Honorary memberships and how none have been bestowed for many years. Laurie included a list of current Open members with this email so that the board members could look through it and think about who may be worthy to become a lifetime member. A MOTION was made by Tammy Vaughn that whoever becomes a member of the Hall of Fame will become an Honorary Lifetime Member. The motion was SECONDED by Casey Jones. Motion CARRIED.

**President's Award-** Jen did not give out the President's Award at Convention because the person receiving the award was not in attendance at the Angora Banquet. The award will be presented at the Angora National Show in Decatur, Illinois in April.

**Yvonne Lyon's Boutique Option-** Yvonne wants to use a website called Victory Pass Originals to sell the NARBC Boutique items. This website is owned by an ARBA rabbit family. NARBC would make proceeds from the sales. People could order throughout the year, and Victory Pass Originals would handle the payment, processing and delivery. They have many options to choose from, and NARBC could do logos through them. This will be tabled until our next meeting, so everyone has a chance to review it.

Live Link for Sweepstakes- A live link for sweepstakes standings is being worked on.

**Spinners Dream Class-** Amanda Fritsch would like a Spinners Dream Class to be offered as a fundraiser show. The challenge is that you might have something that's not in the Standard of Perfection.

**Cage Placement Tags-** Laura Clark is ordering placement tags for the National Angora Show. She will turn in a receipt to June.

**Revision District and Mentoring Facebook Page Rules-** The necessary rules need to be kept but should be updated. We need to promote the Guidebook.

**District Updates: Challenge to the Districts-** Jen is challenging the District Directors to get updates from all areas of their districts.

A MOTION to adjourn the meeting was made by Casey Jones. The motion was SECONDED by Jackie McDonald. The meeting was adjourned at 9:36 pm EST. Our next meeting will be held on Wednesday, January 15, 2025, at 8:00 pm EST via Zoom.

**Status of Membership-** Laurie Penterman reported that we currently have 361 members in the club, 296 being Open members, and 65 Youth members. Since our December meeting, the club has gained seven new Open members and one new Youth member. Eight Open members and one Youth member renewed their membership since the last meeting. Laurie continues to send out renewal notices to expiring members via email.

**Financial Report-** June Abbott reported that the balance in the checking account is \$2,348.16, there is \$29,834.04 in the money market account, and we have a balance of \$723.20 in the PayPal account, for a total cash balance of \$32,905.40. There is \$1,795.14 in the held funds, so there are \$31,110.26 available funds.

#### **OLD BUSINESS**

#### **Policies and Procedures Manual Updates-**

- 1. Youth Director- According to the current PPM, the Youth Director must be at least 12 years of age and under the age of 19 during their time in office. This needs to be revised so Madison can remain the Youth Director until August. The Youth Director can still have a youth voice even if they age out during the term. Let them finish the term. There is no need to recruit for a new Youth Director in the middle of a term.
  - a. A MOTION was made by Jackie McDonald to make the Youth Director position a 2-year term. The motion was SECONDED by Tammy Vaughn. Motion CARRIED.
  - b. A MOTION was made by Lauren Cody to make the age for Youth Director candidates to be between the ages of 12 to 17 as of July 31 when they apply for the position. If they turn 19 years of age during their term they will be allowed to finish their term. The motion was SECONDED by Andrea Evans. Motion CARRIED.
  - c. A MOTION was made by Andrea Evans for our current Youth Director, Madison Wisecup, to finish her term even though she just turned 19. The motion was SECONDED by Jackie McDonald. Motion CARRIED.
- 2. Sweepstakes Information- Our Sanctions Chair, Deb Clemens, joined the meeting. There is an issue with show reports that are coming that have not had sanctions forms attached or sanctions that have been issued. There was discussion about forms that may have been used, and sanctions forms that have been lost in the mail. Discussion on how to prevent further complications with sanctions. A process will be outlined for the future. The paper form may be phased out with an online only sanction request, which Andrea Evans has offered to pilot. There was discussion on using another online payment platform due to increased fees. June will look into what our bank may be able to accommodate. Discussion about using Easy2show to track membership, sanctions and sweepstakes.

**Budget for Next Fiscal Year-** Jen received an email from Laura Clark stating that \$1,000 for ARBA Convention awards was not enough. Last year the cost for the awards for ARBA Convention went under budget, but that was because the some of the awards used were recycled from past years. We will take time to review this and discuss it at the next meeting. A MOTION was made by Andrea Evans to table the budget to our next board meeting. The motion was SECONDED by June Abbott. Motion CARRIED.

**Boutique-** Yvonne Lyons suggested we use a website called Victory Pass Originals to take over the NARBC Boutique. Andrea will contact Victory Pass Originals to find out more information.

**Nationals Update-** Bob Donnell is in charge of running the show stuff. Graham Thomas will ramrod for all 4 Angora breeds.

A MOTION to adjourn the meeting was made by Casey Jones. The motion was SECONDED by June Abbott. The meeting was adjourned at 9:56 pm EST. Our next meeting will be held on Wednesday, February 12, 2025, at 8:00 pm EST via Zoom.



To top such a wonderful day, my Satin Angora doe Prim Rose received the honor of Reserve In Show from judge Cathy Szychulda. What a wonderful day!





English Angora sweeps the Best In Show wins.

Betty Chu brought her tort doe Chu's Aurelia to the show table for the first time at the Christmas show on December 7, 2024, she won one BIS and two RIS in her first outing.

Aurelia's win continues in every show weekend she went to. In mid December, she won one BIS, one RIS and two SBIS. In January 2025 she won one BIS and one SBIS and continued to win the next 6 BIS back to back, a 7 BIS streak; a total of 9 open Best In Show, 3 Reserve In Show and 3 Specialty Best In Show in less than 3 months. That's an accomplishment worth reporting for sure.



### Youth Director: Madison Wisecup

Hello, everyone!

The embrace of Spring is drawing closer, ready to enfold us in a warm, welcoming cocoon of bright, radiant flowers and soft, wriggling noses of young animals slowly exploring their places in the world. And with the Coming of Spring steadily marching closer, heralding the season of crisp, forest green leaves gently swaying with each soft plop of warm, Spring rainwater, begins the approach of the long-awaited Angora Nationals! An event where you can meticulously groom your rabbits with flowing, silky



coats to perfection, accomplishing a rare feat of having beauty encompassed in a physical body, and compete against peers with similar Angoras with fascinating coats to see who best fits the description provided by the ARBA Standard of Perfection! This means that the rabbits being presented at the Angora Nationals should likely be chosen right now, or several rabbits in addition to these just in case a specific one cannot attend Angora Nationals due to unforeseen circumstances. Or, if you are not attending Angora Nationals, then perhaps breed your rabbits for Convention in November so that when you are faced with Angoras with mesmerizing coats positively brimming with brilliance, you can stun the judges! Time is of the essence; don't let it slip from you and forget to prepare for the shows in Spring and the rest of the show! The glamour of Spring's fascinating elements may be beguiling, but don't let it pull you from your plans of showing. Remain steadfast and keep those Angoras groomed to perfection, whilst breeding for Convention kits!

The countdown until Angora Nationals is dwindling perilously low; as a matter of fact, it's right around the corner on April 19th. This doesn't leave much time for deliberating on who goes and who stays, but there is enough time for your favorite Angoras to go through a "last minute coat transition" so that you are not showing them in the midst of this horrendously ugly body and coat change. I can speak from personal experience that you do not want to show them during their coat transition; if at all possible, avoid this! If your own rabbitry bloodline is developed enough that you are fully aware of its every quirk and trait, then try to time the animal to be shown at the best possible time regarding its body condition and coat quality. I understand that these things are often unpredictable, but if you have it timed like clockwork for your Angoras, then use this to your advantage. Try choosing rabbits that are in their peak coat condition right now, but if they're not in top condition right yet are almost to that milestone, then don't take them out of the running just yet! For those that don't plan on attending Nationals or Convention, but still plan on attending local shows, the same can still be applied! If you have favorite shows that you attend every year and are fully aware of the individual traits of each bloodline in your rabbitry, then you can time your rabbits to be showing at the pinnacle of their coat's condition and body's development. Keep this in mind while you are debating who goes and stays during this round of "establishing entries".

I am afraid I must draw this article to a close. I don't have much of anything else to say. Except for: I would like to wish everyone good luck on the showing tables this year! I hope that everyone has beautiful Angora kits when their bred does kindle and give birth to healthy, thriving bundles of joy! These bundles of joy will be your next generation of show animals to stun the judges and fellow Angora exhibitors, but only if you time it properly! You DO NOT want to have an Angora up on the showing table that is going through its "awkward stage", unless you intentionally show it in this way. If you have any questions for me or about anything Angora youth related, just let me know! I am happy to help!



#### **Understanding Wool Block in Wool-Breed Rabbits**

#### **Background**

Wool block, also known as intestinal obstruction, is a relatively common condition encountered by rabbit-savvy veterinarians. This potentially life-threatening condition requires rapid diagnosis and treatment to ensure the survival of the affected rabbit. Wool block may occur more frequently in wool-breed rabbits due to their thick, long coats, which naturally shed and are often ingested during grooming, especially during molting. Without proper management by a rabbit-savvy veterinarian, this condition can quickly progress and have fatal consequences.

#### What Causes Wool Block?

At this time, the exact cause (or causes) of wool block in rabbits remains unknown. However, several contributing factors increase the likelihood of its occurrence, particularly in wool breeds. These rabbits are naturally prone to ingesting significant amounts of hair during their normal grooming habits. This tendency intensifies during seasonal molting when large amounts of fur are shed in the spring and fall.

Hair ingestion and insufficient fiber in the diet can lead to hairballs or blockages within the gastrointestinal tract. Rabbits cannot vomit, so any ingested material must pass entirely through their system. When the digestive system slows down or becomes obstructed, ingested hair can accumulate, forming a dense mass that prevents the normal passage of food and fecal material in the intestines, leading to a life-threatening blockage.

Environmental stressors, such as sudden changes in temperature or humidity, can also disrupt normal digestive motility, exacerbating the risk of wool block. Dehydration, inadequate exercise, and underlying medical conditions further increase susceptibility.

#### What Can Be Done to Prevent Wool Block?

Preventing wool block starts with proper diet and husbandry practices. A high-fiber diet, primarily composed of quality hay, is the most critical factor in maintaining a healthy digestive system. Hay should comprise about 80% of a rabbit's food intake, as the fiber stimulates gut motility and promotes the efficient passage of ingested material.

Supplemental pellets are equally important for wool breeds. Due to their marked hair growth compared to non-wool breeds, wool breeds have higher caloric and nutritional requirements. You may need to provide up to 1 cup of pellets twice daily to meet these needs. Pellets fortified with additional fiber or essential nutrients can further support digestive health. Excessive pellets will lead to digestive issues, obesity, and dental disease.

In addition to diet, regular grooming is critical for wool-breed rabbits. Brushing your rabbit at least once daily during molting can remove loose fur before it is ingested. Regular shaving or clipping can reduce the amount of fur they might ingest while grooming, especially in breeding rabbits and after show season.

Environmental enrichment and exercise also play a role in prevention. Even show and breeding rabbits need opportunities to move and explore, as physical activity promotes healthy gut function. Ensure your rabbit has access to a safe, clean-living space with plenty of room to hop and stretch. While this is more difficult in show and breeding rabbits, it is still vitally important. Consider the use of outdoor runs, which can be retrofitted for rabbits.

#### What Does Wool Block Look Like?

One of the challenges of diagnosing wool block is that early signs are subtle and often mistaken for other conditions. The first indicator may be a slight reduction in the size or quantity of your rabbit's fecal pellets. These changes are often overlooked, especially in breeding situations where monitoring individual rabbits' habits is harder.

As the condition progresses, symptoms become more pronounced. Rabbits may stop eating entirely, resulting in further gut slowdown or complete gastrointestinal stasis. Affected rabbits often exhibit lethargy and spend more time hiding or sitting hunched. Pain-related behaviors, such as teeth grinding, may also be observed.

In advanced cases, rabbits may develop a dangerously low body temperature (below 100°F, as low as 92°F) and a reduced heart rate (less than 180 beats per minute). These are signs of a critical emergency requiring immediate veterinary attention. Dehydration, electrolyte imbalances, and organ shutdowns can occur rapidly.

It's essential for rabbit owners to act at the first sign of trouble. A rabbit's health can deteriorate quickly, and early intervention is often the difference between life and death.

#### **Veterinary Diagnosis and Treatment**

If you suspect wool block in your rabbit, seek veterinary care immediately. Diagnosis often involves a combination of physical examination, imaging (such as X-rays), and bloodwork to assess the rabbit's overall condition. In many cases, veterinarians can see evidence of a blockage on radiographs, and specialists like Dr. Kopp may even be able to diagnose it by physical examination alone.

Treatment depends on the severity of the blockage. Mild cases may respond to supportive care, including fluids to hydrate the rabbit. These fluids are typically given intravenous or in the vein. Fluids under the skin are often inappropriate for wool block. Pain management is also essential to keep the rabbit comfortable during recovery. Many cases of wool block will require a stomach tube to help decrease the stomach size and reduce the risk of stomach rupture; this will not remove the obstruction.

Severe cases, however, may require surgical intervention to remove the blockage. While surgery carries risks, it can be lifesaving when other treatments fail. Thankfully, 80-90% of cases can be medically managed and do not require surgery.

Owners should follow their veterinarian's instructions carefully during recovery, ensuring the rabbit receives proper nutrition and monitoring for signs of relapse.

# Pricing Roving and Yarn By Colleen Boyd (A Touch of Bunny Fiber)

Ok you got into the bunnies and now what do you do with all the fiber? What do I do with my spun yarn? Several times a year I'm asked about pricing my goods, so I decided to share this with all of you budding fiber artists. What I'm suggesting, if from years of experience and researching what others have done. Others might do this differently, which is ok, whatever works for you is my way of thinking. This is to give you a base to start with, feel free to tweak it as needed.

The basic formula is to double the cost of the product (fiber, processing, shipping etc.). The number I'm using is

just an example and may or may not be the current prices of fiber.

Angora (\$160 pound or \$10. Oz)

Fine Wool (\$16.00 a pound or \$1.00 oz)

Fine Alpaca (\$16.00 a pound or \$1.00 oz)

Your fiber blend will be 50% Angora (Rabbit), 25% Fine Alpaca and 25% Fine Wool.

Divided the cost per pound of raw fiber. Then divide the raw fiber cost per pound by 16 (ounces per pound) to give you a price per ounce. We will be figuring out cost by ounce for this article.

The cost of processing roving and yarn will be different depending on the mill you use. These numbers are for this article, they are close but each mill has their own prices.

Most mills I have worked with require in-house washing of fiber before the fiber is made into roving or yarn. The cost is based on dirty weight, in most cases a wool fleece can lose up to 40% lanolin weight during washing. For example, it will cost you \$8.00 per pound for washing so that costs need to be added to your finished product.

Roving Cost: turning your clean fiber into roving, approximately \$13.00 per pound Fingerling Yarn:

Turning the roving and making it into yarn is approximately \$30.00 per pound An additional cost of \$4.00 per pound for exotic fibers (angora, mohair etc.) Skeining Fee: \$4.00 per pound

Washing Fiber Cost: \$12.00 per pound Total Cost for Yarn Per Pound is \$50.00 per pound.

To find your selling price you take the price per ounce and multiply by 2 this will give you your selling price. Your profit margins will be the same as your price per ounce.

This is just a basic equation for estimating costs of finished products. The things you also must consider is your physical location (where you are going to see your items). East and West Cost will pay more for a product then the Midwest. The most important thing is that you feel that you are getting a reasonable price for your product. Not everyone sell there items for the same price and this is your prerogative.



- 8. LATE ENTRIES will be accepted for the National Angora Rabbit Breeders Club, Inc Specialty Show. Late entry fees for the Angoras of the Rockies and National Angora Rabbit Breeders Club specialty Shows. Entry fees will increase by \$3.00 for each rabbit and each wool entry.
- 9. Specialty show entries will be emailed to rabbitrenegades@gmail.com.
- 10. Wool entries must be entered in class judging.
- 11. No breeding will be permitted in the show building unless owners are present.
- 12. All rabbits open and youth must be carried to the judging table by the owner. Youth exhibitors must carry youth rabbits to the table. It is the owner's responsibility to arrange for someone to carry their rabbits to the judging table if he/she is unable to do so.
